Maintaining Historic Integrity

As residents of a Historic District, it is important to take the proper steps when making any changes to the exterior of your home. This not only increases the value of your home, but maintains CVHD as an example of historic integrity. By maintaining this integrity, your home's value will increase over time.

Any exterior work requires a *Certificate of Appropriateness* and a *Building Permit*.

These are both available from the office of **Development Services**. This extra step will ensure that the work meets city requirements and serves as a protection for you, the homeowner. The City of Long Beach does have the ability to require a homeowner to "undo" any non-approved work. Please feel free to contact Lynette Ferenczy at 570-6273. Lynette is a city planner and has expertise in historic district ordinance.
