## A word from the Co-Chairs

We hope you have all had a wonderful and relaxing summer. Believe it or not, next week thousands of smiling parents will be sending their children back to school. Please be extra alert when driving especially near schools or in the morning/afternoon student commute.

## ***What's Happening To Our Streets?***

You may have noticed the "No Parking-Tow Away" signs which have been springing up in the neighborhood, especially along Orange Avenue and on 7<sup>th</sup> Street. While this may prove to be a major inconvenience in the short run, the long term benefits are worth it. The Orange Avenue/7<sup>th</sup> Street Sewer upgrade project began in earnest on September 6<sup>th</sup>. It is tentatively schedule to run through January 16, 2012 barring problems or inclement weather. If you have not received one of the letters distributed by the Long Beach Water Department you may wonder what's happening. The project will upgrade 1300 linear feet of 8-inch sewer pipe to 12-inch extra strength sewer pipe as well as upgrade 1,775 feet of 24-inch pipe to 30-inch pipe. The construction hours are tentatively scheduled for Monday-Friday from 8:30 AM – 3:30 PM. The water department's plans are available on-line or we will be posting a link on the Craftsman Village Website. The project is set to begin at 11<sup>th</sup> and Orange, then head south towards 7<sup>th</sup> street. From there it will travel east on 7<sup>th</sup> street to its completion at Walnut Avenue. One of the goals of this project is to avoid potential sewer back up issues. If you have questions or concerns, the major players involved are:

The co-chairs have already contacted the 1<sup>st</sup> and 2<sup>nd</sup> city council offices in regards to this project. They understand the impact this will have on parking in our neighborhood, especially during the holidays. They will keep in touch with the water department and the contractor to minimize the impact on neighborhood residents as much as possible.

## ***Long Beach Historical Districts Meeting***

On Saturday August 27<sup>th</sup>, Karen Highberger of the city's Cultural Heritage Commission and a long-time resident of Cal Heights hosted a meeting for all of our historical districts. David Waller of Long Beach Heritage was there as a resource and members from the historical districts of Belmont Heights, Bluff Heights, Bluff Park, California Heights, Craftsman Village, Linden Avenue, and the Willmore Historical District were in attendance. The focus on the meeting was to assess the needs of historical districts and to determine ways we could encourage the city to give greater emphasis on preservation. Topics of discussion included certificates of appropriateness, 'weekend warrior' projects that are completed during code enforcement's off hours, as well as the possibility of having on-call weekend support to report potential abuses. Hopefully, the city services will be more supportive of districts' attempts to preserve our heritage.



### **Restoration Trade Fair**

Please join your neighbors for the 4<sup>th</sup> Annual Restoration Trade Fair at Luther Burbank School. Craftsman Village will be amongst the other historic districts participating in this informative event. We need volunteers to sit at our booth for the following times:

History buffs will enjoy a WWII documentary called 'Long Beach Working Hard'. Those wishing to learn a new skill can watch demonstrations on window glazing, blacksmithing or basket weaving. Many local vendors will be on hand with their merchandize and restoration ideas and advice. You can even bring a picture of your home with

### **Mini Clean-Up Teams**

Residents on Hoffman Ave. and Orange Ave. are confronting the issue of litter on their streets. These neighbors have agreed to check their respective street on a regular basis (2-3 times per week) and pick up any trash they encounter. The trash bags and gloves are being provided by Neighborhood Services through the assistance of Gonzalo Sanchez. We appreciate and thank our neighbors for their efforts in keeping our neighborhood clean. Perhaps they will encourage others to do the same.

### **Window Work at Hoffman**

Perhaps you have noticed the construction that is happening at the duplex at Hoffman and the alley. The windows are being replaced with newer vinyl windows. This is being done with a permit and is allowed, not necessarily recommended, because this property falls outside of the historic district boundaries.

Another property, which is located at 1418 E. 9<sup>th</sup> St., is having its windows replaced also. But, in this case, they have a permit, a Certificate of Appropriateness and the windows being used have been approved by the Cultural Heritage Commission.

Please be advised that any exterior changes that are done to your home need a permit and a Certificate of Appropriateness. It is also advised to restore and maintain the original quality of your home's interior features.

Note: The windows used at the 1418 E. 9<sup>th</sup> project can be purchased at B&B Hardware. They are manufactured by Paramount.

## ***Digital Speed Signs***

Traffic and speeding cars have been a hot topic of conversation at many of our meetings. Neighbors are frustrated and concerned about their safety and the safety of their children. Craftsman Village has been working diligently to find some solution to this problem. We have met with the city Traffic Engineer and one of the possible solutions was to install digital speed signs along Orange Ave. Our 1<sup>st</sup> and 2<sup>nd</sup> Council Offices have generously agreed to pay for these two signs. Please take the time to call our council representatives to thank them. Your historic district is also working to have speed humps installed on our three east/west streets; Hellman, 8th and 9<sup>th</sup>. We encourage you to make a phone call in support of installation of speed humps-1<sup>st</sup> District Office-570-6919 and 2<sup>nd</sup> District Office-570-6884. If you don't speak up, your concerns will not be heard!
